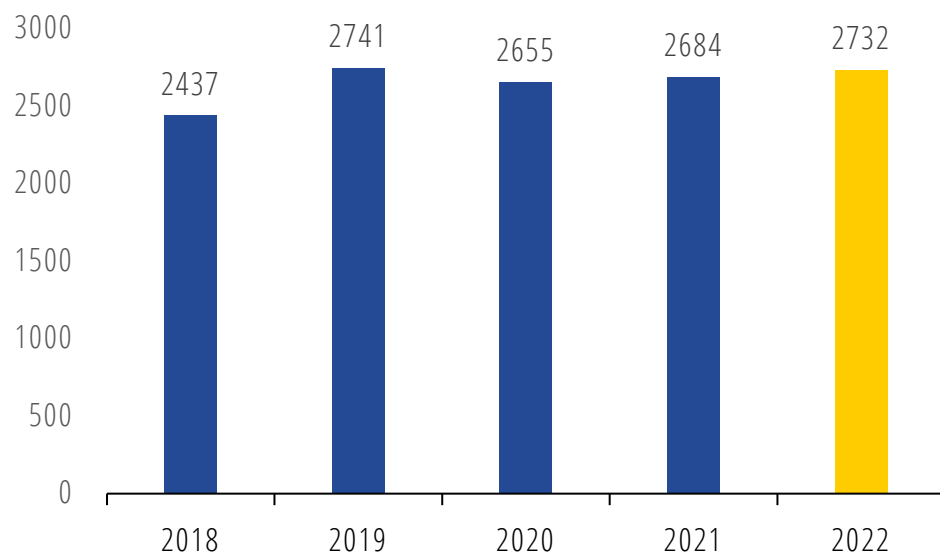

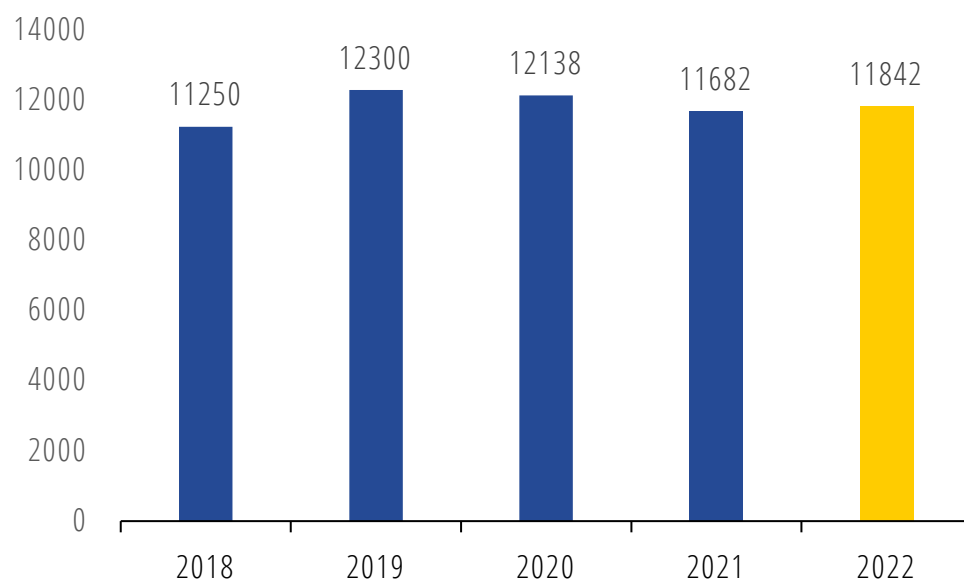
REVENUE MISUMI GROUP
